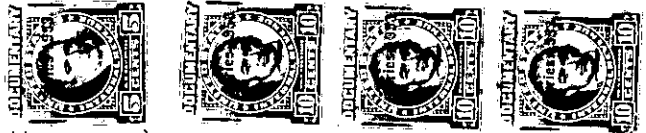

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. S. Hartness,

ALL That certain piece, parcel or lot of land situate, lying and being on the West side of the New Buncombe Road and the Southeast side of Goldsmith Street in the County of Greenville, State of South Carolina, as is more particularly shown on Composite Plat of property of R. E. Hughes and I. A. Giles, Jr. and Sarah J. Hartness and T. S. Hartness, compiled May 6, 1954, by A. K. Campbell and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the West side of the New Buncombe Road in line of property this day conveyed by the Grantors to Sara J. Hartness and T. S. Hartness, and running thence along the line of said property, S. 69-29 W. 141.1 feet to a point; thence turning and continuing with the line of said property, N. 40-44 W. 131.9 feet to an iron pin on the Southeast side of Goldsmith Street; thence turning and running along the Southeast side of Goldsmith Street, N. 48-58.5 E. 76.14 feet to an iron pin; thence turning and running N. 69-29 E. 171.9 feet to an iron pin on the West side of New Buncombe Road, said iron pin being S. 0-52 W. 150 feet from an iron pin at the intersection of the Southeast side of Goldsmith Street and the West side of New Buncombe Road; thence turning and running along the West side of New Buncombe Road, S. 0-52 W. 150.1 feet, the point of beginning.

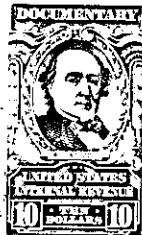
