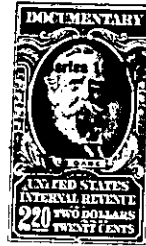

BATES - - - - - in the State aforesaid, in consideration of the sum of THREE THOUSAND EIGHT HUNDRED NINETY & 80/100- - - - - DOLLARS, and ASSUMPTION OF MORTGAGE DESCRIBED BELOW: to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM H. MCKINNEY, his heirs and assigns:

All that piece, parcel or lot of land with buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 8, Plat of Skyland Park as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "L", page 41 and having the following metes and bounds to wit:

BEGINNING at an iron pin on the Southwesterly side of Bates Avenue, joint front corner Lots 7 and 8 and running thence S-55-06 W. 170 feet to an iron pin, joint rear corner Lots 7 and 8; thence S. 36-13 E. 53.9 feet to an iron pin, joint rear corner Lots 8 and 9; thence N. 53-47 E. 170 feet to an iron pin on the Southwesterly side of Bates Avenue, joint front corner Lots 8 and 9; thence along the Southwesterly side of Bates Avenue N. 36-13 W. 50 feet to an iron pin, point of beginning. Bates Avenue is also known as Skyland Drive.

As a part of the consideration hereof, the grantee agrees to assume and pay according to its terms that certain note and mortgage given by the grantors to Fidelity Federal Savings and Loan Association on which there is a balance due of \$4,609.20; said mortgage is recorded in Mortgages Volume 561, page 87.

The grantee will pay the 1954 taxes.
