to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John R. Folsom and Anita A. Folsom, their heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being at the intersection of Osceola Drive and Balentine Drive in the City of Greenville, County of Greenville, State of South Carolina, and known and designated as Lot No. 5 of the plat of Greenrier, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book EE at page 87, and according to said plat having the following metes and bounds to wit:

BEGINNING at an iron pin on the northeastern side of Osceola Drive, joint front corner of Lots 4 and 5 and running thence along the joint line of said lots N. 61-00 E. 162.5 feet to an iron pin; running thence S. 27-42 E. 110 feet to an iron pin on the northern side of Balentine Drive; running thence along the northern side of Balentine Drive S. 61-00 W. 135 feet to an iron pin at the intersection of Balentine Drive, which intersection is curved, the chord of which is N. 74-00 W. 35.3 feet to an iron pin on the northeastern side of Osceola Drive; running thence along the northeastern side of Osceola Drive N. 29-00 W. 85 feet to an iron pin, point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

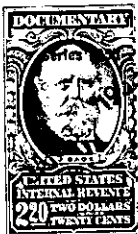
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
