Fore, as shown on a plat thereof made by Dalton & Neves, September 1953, recorded in Plat Book EE, at page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Manchester Avenue at the joint front corner of lot Nos. 93 and 94 and running thence with the joint line of said lots S. 25-15-W. 240 feet to an iron pin; thence with the rear line of lot No. 74, N. 64-45 W. 100 feet to an iron pin, joint rear corner of lots Nos. 92 and 93; thence with the joint line of said lots, N. 25-15 E. 240 feet to an iron pin on the Southern side of Manchester Avenue; thence with said Avenue, S. 64-45 E. 100 feet to the beginning corner.
