That I, John G. Wilson in the State aforesaid, in consideration of the sum of Five and No/100ths (\$5.00) - - - - - DOLLARS, and love and affection for my son, the grantee herein, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Graves H. Wilson, Sr., his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, designated as Lot # 3 or a Plat of Property of John G. Wilson, the same being recorded in the R. . . C. Office for Greenville County in Plat Book "7" at page 163, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Cyrus Court, at the joint front corner of Lots # 3 and 4, and running thence along the curve of Cyr's Court N. 36-20 W. 62 feet to an iron pin; thence still along the curve of Cyr's Court N. 57-22 W. 27.9 feet to an iron pin; thence along the rear line of Lots # 1 and 2 S. 29-56 W. 216.2 feet to an iron pin; thence along the rear line of Lot # 3 S. 40-49 E. 199.8 feet to an iron pin; thence along the side line of Lot # 4 N. 4-28 E. 262.4 feet to an iron pin at the point of beginning.
