in consideration of the sum of three hundred fifty no/100 DOLLARS;

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. C. Lee, his heirs and assigns forever:

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, near the southern side of Arch Street Extension, being a portion of Lots Nos. 29 and 30 according to a plat of the property of F. B. Massingale made by J. Coke Smith & Son, May 15, 1957, and described as follows:

BEGINNING at a stake in the rear line of Lot No. 29, which stake is 55 feet east of the joint corner of Lots Nos. 28 and 29, and running thence in a northwesterly direction, with line of lot now owned by Emmett Lee ( which line is parallel to the joint line of Lots Nos. 28 and 29) 115 feet to a stake; thence in a line parallel with the rear line of Lot No. 30, 131 feet, more or less, to a stake in the eastern line of Lot No. 30; thence S. 65-00 E. with the eastern line of Lot No. 30, 144 feet, more or less, to a stake in rear line of Lot No. 30; and thence with the rear line of Lots 30 and 29, 213 feet to the beginning corner, together with a right-of-way 6 feet in width extending along the eastern side of Lot No. 30 as a means of ingress and egress from Arch Street Extension to the lot hereby conveyed.

The above described lot of land was conveyed to me by Wister Curry by deed dated October 29, 1954, and recorded in the R. M. C. Office for Greenville County in Book 511, page 171.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

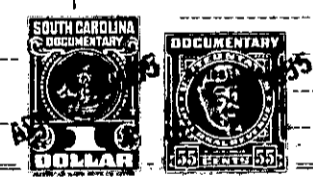
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
