Know All Men by These Presents:

That I, Irven K. Williams in the State aforesaid, in consideration of the sum of Four Thousand Seven Hundred Thirty and 43/100 DOLLARS, and assumption of mortgage indebtedness set forth below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy W. Boggess, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina known as lot no. 177 according to plat of Sherwood Forest of record in the R.M.C. Office for Greenville County in Plat Book GG at Pages 2 and 3, made by Dalton & Neves, August, 1951, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Forest Green Road, which iron pin is the joint front corner of lots nos. 177 and 178, which iron pin is situate 60 feet from the curved intersection of Robin Hood Road and Forest Green Road, and running thence along the line of lot no. 178, N 78-02 E, 167.7 feet to an iron pin in the line of lot no. 179; thence with the line of lots nos. 179 and 176, N 20-17 W, 138 feet to the southeastern side of Robin Hood Road; thence with said road, S 57-47 W, 124.5 feet to an iron pin; thence with the curved intersection of Robin Hood Road and Forest Green Road, the chord of which is S 25-24 W, 42.2 feet to an iron pin on Forest Green Road; thence with the eastern side of Forest Green Road, S 6-58 E, 60 feet to the point of beginning. Being the same property conveyed to me by deed book 504 page 449.

The grantee assumes and agrees to pay the balance due on that note and mortgage executed to C. Douglas Wilson & Co. in the original sum of \$11,900.00 recorded in mortgage book 617 at page 369; said balance due is \$11,769.57.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s)'s Heirs and Assigns against the grantor(s) and the grantor(s)'s Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
