in the State aforesaid, in consideration of the sum of Ten Thousand Eight Hundred and No/100----- DOLLARS,

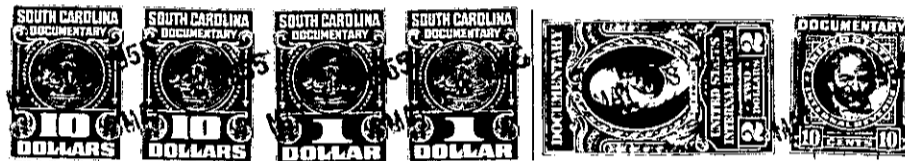
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. C. RACKLEY & HELEN H. RACKLEY, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Northwest side of Darlington Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 1 on plat of property of William B. Ducker, made by Dalton & Neves, Engineers, December, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "HH", page 201, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Darlington Avenue, at joint front corner of Lots 1 and 2, and running thence with the line of Lot 2, N. 60-21 W., 85 feet to an iron pin; thence N. 11-07 E., 58.3 feet to an iron pin on the South side of Dykeson Avenue; thence along the South side of Dykeson Avenue, S. 78-53 E., 109.2 feet to an iron pin at the Southwest corner of the intersection of Dykeson Avenue with Darlington Avenue; thence along the Northwest side of Darlington Avenue, S. 29-39 W., 90 feet to the beginning corner.

This is a portion of that property conveyed to the grantor herein by deed of O. C. Freeman, dated November 12, 1954, and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 512, at page 91.
