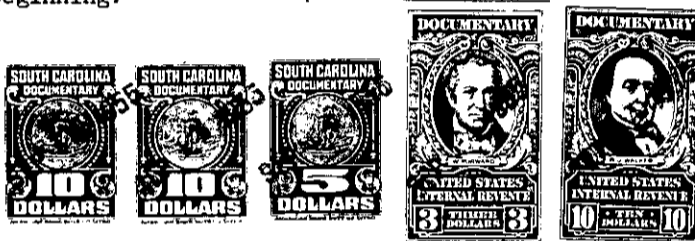
Harold J. Derry, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the Northeastly corner of the intersection of Wedgewood Drive and Meadow Crest Circle, near the City of Greenville, South Carolina, being shown as Lot No. 23 on the plat of North Meadow Heights as recorded in the RMC Office for Greenville County, S. C., in Plat Book "W", page 183, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Wedgewood Drive at the Northeastly corner of the intersection of Wedgewood Drive and Meadow Crest Circle, and running thence along the Northwesterly side of Wedgewood Drive N 62-14 E 101.5 feet to an iron pin, joint front corner of Lots Nos. 22 and 23; thence along the joint line of Lots Nos. 22 and 23 N 27-46 W 140 feet to an iron pin on the line of Lot No. 24; thence along the joint line of Lots Nos. 23 and 24 S 62-14 W 128.6 feet to an iron pin on the Northeastly side of Meadow Crest Circle; thence along the Northeastly side of Meadow Crest Circle S 28-30 E 115 feet to an iron at the intersection of Meadow Crest Circle and Wedgewood Drive; thence around said intersection on a curve, the chord of which is S 73-08 E 35.6 feet to the point of beginning.
