All those certain pieces, parcels or lots of land in Greenville Township, Greenville County, state of South Carolina, being known and designated as Lots 21 and 22, of Section C as shown on plat of subdivision known as Washington Heights, said plat being recorded in the R. M. C. Office for Greenville County in plat book M page 107, and according to said plat having the following metes and bounds, to-wit:
