WALTER D. SHEALY, JR. AND CELIA S. SHEALY:

All that certain piece, parcel or strip of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina, and being all of Lot No. 3 and a portion of Lot No. 2 of University Circle, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book "Y" at page 111, and, according to said plat and according to a more recent plat prepared by Piedmont Engineering Service, Greenville, S. C., dated July 10, 1953, entitled "Property of Ira W. Stokes, Greenville, S.C.," the within conveyed premises have the following metes and bounds, courses and distances, to-wit:

BEGINNING at a point on the Northern side of Campbell Street, joint front corner of Lots Nos. 3 and 4, and running thence with the joint line of the said lots, N. 27-14 W. 180 feet to an iron pin at the joint rear corner; thence along the rear line of Lots Nos. 3 and 2 S. 85-15 E. 110 feet to an iron pin, joint rear corner of Lot No. 2; thence S. 16-24 E. 150 feet to an iron pin, the joint front corner of Lots Nos. 2 and 3 on Campbell Street; thence along the Northern side of Campbell Street S. 83-30 W. 70 feet to an iron pin, the point of beginning.
