in consideration of the sum of Seven Hundred and No/100 (\$700.00) - - - - - DOLLARS,

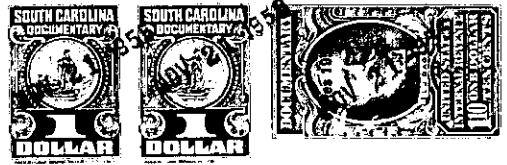

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots No. 74 and 76 as shown on plat of Pine Brook Development made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book "Z", at Page 148, and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on Western side of Bidwell Street, joint front corner of Lots 74 and 72, thence along line of said lots, S. 56-29 W. 150 feet to an iron pin, joint rear corner of said lots; thence N. 33-31 W. 150 feet to an iron pin, joint rear corner of Lots 78, 76, 57 and 55; thence along line of lot 79, N. 56-29 E. 150 feet to an iron pin on Bidwell Street; thence along Bidwell Street, S. 33-31 E. 150 feet to an iron pin, the point of beginning.
