

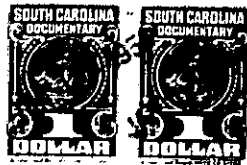

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
GEORGE H. HERNDON AND FRANCES J.HERNDON:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being shown as Lot No. 4 on a plat entitled "Map of Springview, Greenville Co., S. C., Property of Effie C. Berry" prepared by Dalton & Neves, dated June, 1954 and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB at page 161, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Farley Avenue at the joint front corner of Lots 3 and 4; thence with the line of Lot 3 N. 1-02 W. 113.8 feet to an iron pin at the joint rear corner of Lots 1, 3, 4 and 5; thence with the line of Lot 5, S. 82-07 E. 139.4 feet to an iron pin on the Western side of Elgin Court; thence with the Western side of Elgin Court S. 19-47 E. 46.4 feet to an iron pin; thence continuing with the Western side of Elgin Court S. 0-28 W. 37 feet to an iron pin; thence with the curve of the intersection of Elgin Court and Farley Avenue, the chord of which is S. 51-21 W. 31.7 feet to an iron pin on the Northern side of Farley Avenue; thence with the Northern side of Farley Avenue N. 84-29 W. 55.9 feet to an iron pin; thence continuing with the Northern side of Farley Avenue N. 88-44 W. 61 feet to an iron pin; thence continuing with the Northern side of Farley Avenue S. 88-54 W. 9.7 feet to an iron pin, the point of beginning.

The above described property is conveyed subject to certain existing and recorded rights-of-way and restrictions.

This is the identical property conveyed to the grantor herein by deed of Effie C. Berry, dated February 15, 1955, and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 521, at page 172.

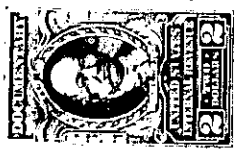
