All that certain piece, parcel or lot of land situate, lving and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Fifty-Three (53), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in 'lat , reference to which plat is hereby made, said lot of Book "FF", at page.: 25, land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the Southwestern side of Clearview Avenue as shown on said plat at the corner common to Lots 33 and 53, and running thence South 35-45 "est along the dividing line between Lots 33 and 53, one hundred fifteen and eight-tenths (115.8) feet at an iron pin at the correr of Lot 34; thence South 34-25 East along the dividing line between Lots 31 and 35, one hundred (100.0) feet to an iron at the corner commont to Lots 32 and 53; thence North 47-29 East along the dividing line between Lots 52 and 53, one hundred fifty-three (153.0) feet to an iron pin on the Southwestern side of Clearview Avenue; thence along said Clearview Avenue North 54-15 Vest one hundred twentyfive (125.0) feet to the place of beginning.
