- ROBERT T. HARRISON, HIS HEIRS AND ASSIGNS FOREVER -

All those certain pieces, parcels or lots of land in the County of Greenville, State of South Carolina, known and designated as Lots Nos. 39 and 40 on Plat of Property of C. E. Lloyd, White Horse Heights, prepared by C. C. Jones, C. E., 20 December 1952, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "BB", Page 135, and having according to said plat, when described together, the following metes and bounds, to wit:
