Know All Men by These Presents:

That I, H. R. Stephenson, in the State aforesaid, in consideration of the sum of Fourteen Hundred Fifty and no/100 (\$1,450.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Thomas P. Moore, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southwesterly side of Woodberry Way, near the City of Greenville, S. C., being shown as Lot No. 12 on the plat of Hollyvale as recorded in the RMC Office for Greenville County, S. C. in Plat Book "Y", page 131, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Woodberry Way at a point 473.1 feet north-west of the westerly corner of the intersection of Woodberry Way and State Park Road, said pin being the joint front corner of Lots Nos. 11 and 12, and running thence along the southwesterly side of Woodberry Way N 17-30 W 100 feet to an iron pin, joint front corner of Lots Nos. 12 and 13; thence along the joint line of said lots S 78-00 W 280 feet to an iron pin on a branch; thence with the branch as the line, a traverse line being S 43-21 W 211 feet to an iron pin; thence continuing with the branch as the line, the traverse line being S 7-07 E 32.3 feet to an iron pin, joint rear corner of Lots Nos. 11 and 12; thence along the joint line of said lots N 71-36 E 470 feet to the point of beginning.

As part of the consideration hereof this property is conveyed subject to the building restrictions applicable to Hollyvale as recorded in the RMC Office for Greenville County, S. C. in Deed Book 440, page 537.
