KNOW ALL MEN BY THESE PRESENTS, That I, -- Truman Henderson

in the State aforesaid, in consideration of the sum of Ten dollars, and love and affection for my wife, Laura Henderson, Dollars

to me in hand paid at and before the sealing of these presents by Laura Henderson

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Laura Henderson, her heirs and assigns:-

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, School District #285, just outside the City limits of Greer, on the northeast side of Mostella Road (or North Main Street Extension), adjoining lands of C.B.Henderson, Vernon Duncan and said road, and having the following courses and distances, to-wit:-

Beginning on an iron pin in center of said Mostella Road (or N Main St Ext), and on Vernon Duncan's line; thence with the Duncan line, S 80-35 E 374 feet to iron pin on the Duncan line; thence S 19-35 E 155.7 feet to iron pin near a 3-room dwelling house; thence S 35-25 W 45.5 feet to iron pin near pump house; thence S 49-35 W 86 feet to a point in center of said Mostella Road (or N Main St Ext); thence with said Road or Street Ext. N 47-35 W 446 feet to the beginning corner, containing one and 27/100 acres, more or less, together with all improvements on same; and being same conveyed to me by deed of C. B. Henderson 9-2-37, and recorded in Vol. 193 page 152.

ALSO, that certain other lot or parcel of land, with the improvements on same, in said Township, School District, County and State, on the Mostella Road, and having following courses and distances, to-wit:-

Beginning at iron pin in center of Cross Road and the new road to Greer, and runs thence in a northwestern course with the center of said road 21 rods and 15 links to iron pin at center of the old Greer Road; thence with center of old road 16 rods and 18 links to iron pin 3x; thence with the Wilson Grave Yard line 19 rods and 9 links to iron pin 3x; thence with the Wilson Grave Yard line, 9 rods and 17 links to iron pin 3x; thence in an east course 4 rods and 11 links to center of new road; thence with the center of said new road, 23 rods and 5 links to the beginning point, and containing two and one-fourth acres, more or less; and being the same conveyed to me by deed of E. B. Crain on March 10-1944, and recorded in Vol. 261 page 404.

Also, that other lot or parcel of land with all improvements thereon,
