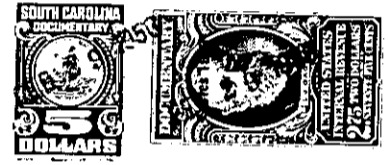

All that certain piece, parcel or lot of land lying and being on the westerly side of Timberlake Drive, near the City of Greenville, S. C., being shown as Lot No. 39 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Timberlake Drive at a point 730 feet north of the northwesterly corner of the intersection of Timberlake Drive and Spartanburg Road, said pin being the joint front corner of Lots Nos. 39 and 40, and running thence along the westerly side of Timberlake Drive N 7-40 E 90 feet to an iron pin, joint front corner of Lots Nos. 39 and 38; thence along the joint line of said Lots N 82-20 W 250.8 feet to an iron pin in the line of Lot No. 32; thence S 2-03 W 90.5 feet to an iron pin in the line of Lot No. 30; thence along the joint line of Lots Nos. 39 and 49 S 82-20 E 242 feet to the point of beginning.
