J. W. Smith and Velma L. Smith, their heirs and assigns, forever:

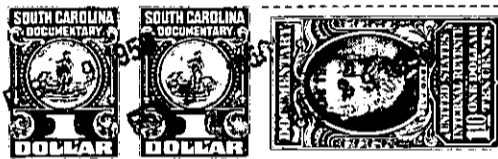
