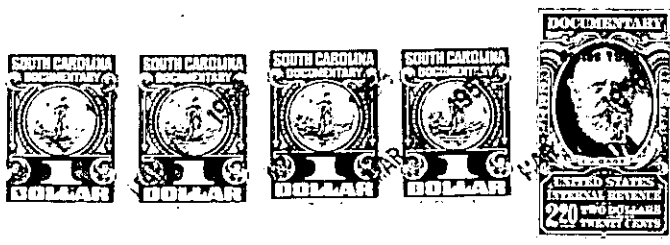

All that piece, parcel or lot of land, situate, lying and being in The County of Greenville, State of South Carolina, in Chick Springs Township, being known and designated as Lot 233 on the Western side of Elizabeth Drive as shown on a plat of Property of Robert J. Edwards recorded in the R. M. C. Office for Greenville County in Plat Book EE at page 61, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Elizabeth Drive at the joint front corner of Lots 232 and 233, and running thence with the line of Lot 232 S. 56-30 W. 200 feet to an iron pin; thence N. 33-30 W. 100 feet to an iron pin at the joint rear corner of Lots 233 and 234; thence with the line of Lot 234 N. 56-30 W. 200 feet to an iron pin on the Western side of Elizabeth Drive; thence along the Western side of Elizabeth Drive S. 33-30 E. 100 feet to the point of beginning.
