TRAXLER in the State aforesaid, in consideration of the sum of FIVE THOUSAND AND NO/100- - - - - DOLLARS, and assumption of mortgage described below; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BETTY P. PITTS, her heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 398, Pleasant Valley, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BB", page 163, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Pasadena Avenue, joint front corner Lots 397 and 398, and running thence S. 0-08 E. 188.8 feet to an iron pin, joint rear corner Lots 397 and 398; thence N. 45-55 E. 83.4 feet to an iron pin, joint rear corner Lots 398 and 399; thence N. 0-08 W. 130.8 feet to an iron pin on the Southerly side of Pasadena Avenue, joint front corner Lots 398 and 399; thence along the Southerly side of Pasadena Avenue, S. 89-52 W. 60 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to The First National Bank, as executor, in the principal amount of \$4,000.00; said mortgage recorded in Mortgages Volume 670, page 205.
