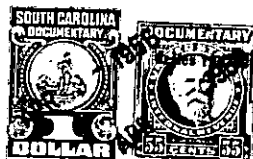

That I, M. W. Fore in consideration of the sum of FOUR HUNDRED AND FIFTY & NO/100 (\$450.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Garth E. Green, Sr. and Garth E. Green, Jr., their heirs and assigns, forever:

All that piece parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 41 on plat of Brookwood recorded in the R. M. C. Office for Greenville County in Plat Book BB, at page 27, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the Southern side of Howard Drive at the joint front corner of lots 40 and 41 and running thence with the line of said lots S. 2-15 W. 165 feet to an iron pin; thence with the rear line of lots 41 and 21, S. 87-30 E. 100 feet to an iron pin; thence with the line of Lots 41 and 42, N. 2-15 E. 165 feet to an iron pin on the Southern side of Howard Drive; thence with Howard Drive, N. 87-30 W. 100 feet to the beginning corner.

This conveyance is subject to the following restrictions:

That the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than \$5000.00 shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35') feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50') feet, or more frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This conveyance is subject to all easements and rights of way of record.

Grantees to pay 1956 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
