ALL That piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 12 on plat of property of Chestnut Hills, recorded in the Office of the R. M. C. for Greenville County in Plat Book GG, Page 35, and being more particularly shown on plat of property of Joseph D. RaPosa, dated June 14, 1956, prepared by R. K. Campbell, and having according to said plat the following metes and bounds:

BEGINNING At an iron pin on the Northern side of Butternut Drive at the joint front corner of Lots 11 and 12, said iron pin being 890 feet West of Grove Road, and running thence along the Northerly side of Butternut Drive, N. 82-05 W. 70 feet to an iron pin, joint front corner of Lots 12 and 13; thence turning and running along the joint line of Lots 12 and 13, N. 7-55 E. 150 feet to an iron pin on the Northern side of a five-foot utility easement, joint rear corner of Lots 13 and 12; thence turning and running along the rear line of Lot 12, S. 82-05 E. 70 feet to an iron pin, joint rear corner of Lots 11 and 12; thence along the joint line of Lots 11 and 12, S. 7-55 W. 150 feet to an iron pin on the Northern side of Butternut Drive, the point of beginning.
