in consideration of the sum of Eight Hundred Sixty-four and 60/100----- DOLLARS,

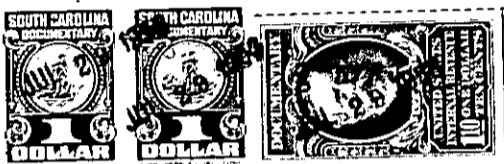
