in consideration of the sum of Two Hundred Sixty and No/100----- (\$260.00)----- DOLLARS, in the State aforesaid,

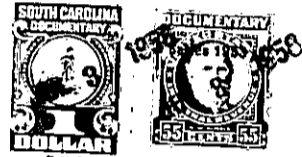
