to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ANNE M. LINDSEY, her heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 50, Stone Lake Heights, Section 2, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "W", page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Lake Forest Drive, joint front corner Lots 49 and 50, and running thence along the joint line of said lots, N. 86-08 W. 279.6 feet to a point on the margin of Stone Lake, the joint rear corner of said lots; thence along the margin of Stone Lake, S.18-41E. 128.4 feet to a point on the margin of Stone Lake; the joint rear corner of Lots 50 and 51; thence along the joint line of said lots, S.88-20E. 239.5 feet to an iron pin on the Western side of Lake Forest Drive, the joint front corner of said lots; thence along the Western side of Lake Forest Drive, N. 2-36 E. 110 feet to the beginning corner.
