The above described property is the identical property conveyed to the Lessee herein by two deeds as follows: The deed of A. B. Green, et al, as Trustees dated July 29, 1950 and recorded in the R.M.C. Office for Creenville County, South Carolina, in Deed Volume 415 at Page 492 conveying 15.14 acres, more or less, and deed of John Michard Vaughn and Irene McGee Vaughn dated July 29, 1950 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Volume 415 at Page 495 conveying 21.12 acres, more or less.

The above metes and bounds description includes within its boundaries two strips of land as shown on the aforementioned recorded plat, each strip having a width of thirty (301) feet. Said strips of land lie immediately North of the center line of the Charleston & Western Carolina Railway; are designated on the aforementioned recorded plat as the new right-of-way of the Charleston & estern Carolina (C. & W.
