FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is WORRILL HARDWOOD COMPANY, INC.

THIRD: That the principal place of business is Greenville, South Carolina

FOURTH: That the general nature of the business which it is proposed to do is to engage in the manufacture, assembling, processing, acquiring, buying, trading, selling, importing, exporting, leasing or otherwise disposing of and dealing in and with furniture, lumber, building equipment and supplies, textiles, yarns, wearing apparel and mill work, wood, plastic and metal products of all types and kinds; to acquire, sell, lease and dispose of real estate for development, rental and investment; to engage in any general mercantile or trading enterprise and to acquire and conduct any business firm enterprise or composition and generally to do any conduct any business firm, enterprise or corporation and generally to do anything which a corporation may do under the laws of the State of South Carolina.
