to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Grady S. Hayes and Flora K. Hayes, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southerly side of East Heathwood Drive, near the Town of Taylors, S. C., being shown as Lot No. 43 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of East Heathwood Drive at the corner of the intersection with Whitman Drive, and running thence along the southerly side of East Heathwood Drive S 80-06 E 75 feet to an iron pin, joint front corner of Lots Nos. 42 and 43; thence along the joint line of said Lots S 9-54 W 200 feet to an iron pin in the line of Lot No. 44; thence with the line of Lot No. 44 N 80-06 W 100 feet to an iron pin on the easterly side of Whitman Drive; thence along the easterly side of Whitman Drive N 9-54 E 175 feet to an iron pin at the intersection of said Drive with East Heathwood Drive; thence around said intersection on a curve, the chord of which is N 54-54 E 35.2 feet to the point of beginning.
