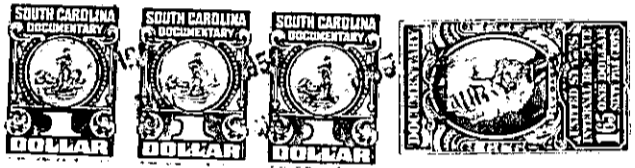

H. MARTIN and W. A. WALDROP, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 61 of a subdivision known as Isaqueena Park, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book P at Pages 130-131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Harrington Avenue at the joint front corner of Lots 60 and 61 and running thence S 52-30 W 175 feet to a point at the joint rear corner of Lots 60 and 61; thence N 37-30 W 70 feet to a point at the joint rear corner of Lots 61 and 62; thence N 52-30 E 175 feet to a point on the Southwestern side of Harrington Avenue at the joint front corner of Lots 61 and 62; thence with the Southwestern side of Harrington Avenue S 37-30 E 70 feet to the point of beginning.
