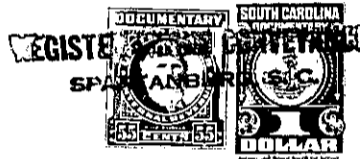
That I, Katherine June S. Hembree, in the State aforesaid,

William C. Solesbee and his heirs and assigns forever:

All my right, title and interest in and to, all that certain parcel or  
tract of land containing Sixty-three and six-tenths (63.6) Acres, more or  
less, situated on the East side of State Highway No. 14, near Gowensville and  
northward therefrom, in Greenville and Spartanburg Counties, designated as  
Tracts Nos. 3 and 4 of the T.J. Earle Estate according to survey and plat  
thereof by W.N. Willis, Surveyor, dated July 3, 1919, and recorded in Plat  
Book "E", page 140, R.M.C. Office for Greenville County. Tract No. 3 is  
described as containing 29.8 acres, more or less, and Tract No. 4 as  
containing 34.8 acres, more or less.

The above is the same land conveyed to W.W. Solesbee by deed of J.B.
