Master in and for the County aforesaid, to Edd Foster  
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County  
of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release  
unto the said Edd Foster

"All that parcel, tract or lot of land situated near Jubilee Colored Baptist Church, and closer still to Greer's Community Store, being in Oneal Township, County and State aforesaid, adjoining lands of Butler Lewis Estate on the West, and other lands of the grantor on the North, East and South, and having the following metes and bounds: BEGINNING at a stone on line of Butler Lewis Estate, and with same line W.  $46\frac{1}{2}$  W. 103 feet and 7 inches to iron pin; thence N.  $43\frac{1}{2}$  E. 108 feet and 6 inches to iron pin; thence S.  $46\frac{1}{2}$  E. 103 feet and 7 inches to iron pin; thence S.  $43\frac{1}{2}$  E. 108 feet and 6 inches to the beginning corner."

The above described property is hereby conveyed to the grantee herein pursuant to an Order of the Court in the above entitled action and is with out any monetary consideration. For that reason, it is not necessary to place any revenue stamps on this deed.
