in consideration of the sum of ONE THOUSAND FIFTY AND NO/100-----(\$1,050.00)----- DOLLARS,

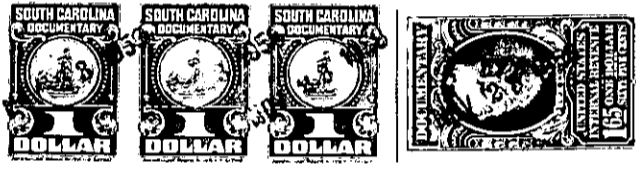
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 5 of the Property of W. T. Patrick and W. R. Timmons, jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 94, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Eisenhower Avenue at the joint front corner of Lots 4 and 5 and running thence S 14-16 E 175 feet to a point at the joint rear corner of Lots 4 and 5; thence N 75-44 E 16.25 feet to a point; thence N 73-19 E 58 feet to a point at the joint rear corner of Lots 5 and 6; thence N 16-41 W 175 feet to a point on the Southern side of Eisenhower Avenue at the joint front corner of Lots 5 and 6; thence with the Southern side of Eisenhower Avenue S 73-19 W 54.3 feet to a point; thence continuing with the Southern side of Eisenhower Avenue S 75-44 W 12.7 feet to the point of beginning.
