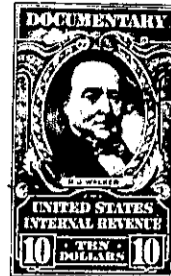
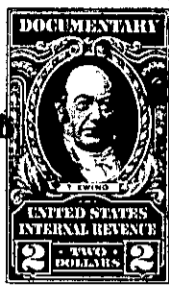

## The State of South Carolina,

COUNTY OF GreenvilleKNOW ALL MEN BY THESE PRESENTS, That Woodfields, Inc.a corporation chartered under the laws of the State of South Carolina

and having its principal place of business at

Greenville in the State of South Carolina for and in considerationof the sum of Ten Thousand, Six Hundred and No/100 - (\$10,600.00) - Dollars,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Laramie D. Starling, his heirs and assigns forever:

All those certain pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, Cartt Township, being known and designated as Lot No. 206 and portions of Lots Nos. 205 and 207 of a Subdivision known as Belle Meade, Sections 1 and 2, according to a plat thereof prepared by Piedmont Engineering Service June, 1954, and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Pages 116 and 117, and having, according to a plat of the property of Laramie D. Starling, prepared by C. C. Jones and associates, Engineers, July 10, 1956, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Pine Creek Drive in the front line of Lot No. 207, which pin is 1.0 feet in the direction S. 64-54 E. from the joint front corner of Lots Nos. 206 and 207, and running thence along a line through Lot No. 207, N. 14-12 E. 157.9 feet to a point in Brushy Creek; thence following the meanders of Brushy Creek as the line, the traverse lines being N. 62-00 W. 10 feet (to the joint rear corner of Lots Nos. 205 and 206), N. 61-13 W. 122.6 feet (to the joint rear corner of Lots Nos. 205 and 206), and N. 52-24 W. 10.8 feet to a point in said creek in the rear line of Lot No. 205; thence on a line through Lot No. 205, S. 12-45 W. 100.3 feet to an iron pin on the northern side of Pine Creek Drive; thence along the northern side of Pine Creek Drive, following the curvature thereof, the chord of which is S. 82-15 E. 15 feet to an iron pin, the joint front corner of Lots Nos. 205 and 206; thence continuing along the northern side of Pine Creek Drive, the chord of which is S. 70-11 E. 67 feet to a point; thence continuing along the northern side of Pine Creek Drive, S. 64-54 E. 53 feet to the beginning corner; being a portion of the property conveyed to Woodfields, Inc. by Derby Heights, Inc. by deed dated June 26, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 555, page 459.
