Crow as made by J. C. Hill, Surveyor, on September 13, 1954, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of a private road leading to Piney Road, and running thence N. 32 W. 125 feet to an iron pin in line of other property of Fred M.
