

Know All Men by These Presents:

That I, C. M. Jones in the State aforesaid, in consideration of the sum of Five Thousand and No/100--------- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John W. Walker, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, containing 61 acres, more or less, being known and designated as Tract No. 4 of the property of the heirs of J. M. Jones as shown on a plat thereof prepared by W. A. Hester, Surveyor, January 4, 1922 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stone on Robert Y. Rosamond's line, and running thence N. 49 1/4 E. 25.50 chains to a white oak; thence N. 21 W. 12.00 chains to a sweet gum; thence S. 70 W. .70 chains to a stone; thence N. 79 1/2 W. 4.45 chains to a stone; thence N. 25 W. 3.50 chains to a stone; thence N. 63 W. 1.90 chains to a stone; thence up Buck Horn Creek in a southwesterly direction, 28.69 chains to a stone on Tract No. 3; thence S. 41 3/4 E. 12.72 chains to a stone, P. O. gone; thence S. 33 1/4 E. 16.30 chains to a stone on Sloan Batson's line to the beginning corner; less, however, 5.03 acres conveyed to Gertrude P. Lawson by deed dated September 5, 1952 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 462, at page 415; being the same property conveyed to C. M. Jones by two deeds, one from Georgeanne Jones by deed dated February 20, 1943 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 255, Page 86 and the other being from T. G. Jones by deed dated March 21, 1946 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 289, Page 282 (less 5.03 acres conveyed to Gertrude P. Lawson by deed recorded in Deed Vol. 462, Page 415).
