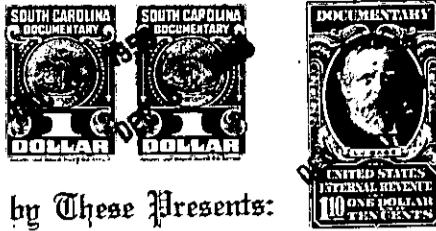

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 26 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Woodbriar Court at the joint front corner of Lots 26 and 27 and running thence S 45-08 E 212.3 feet to a point at the joint rear corner of Lots 26 and 27; thence N 31-02 E 100 feet to a point on the Southwestern side of Indigo Street at the joint rear corner of Lots 26 and 12; thence with the Southwestern side of Indigo Street N 51-32 W 178.6 feet to a point; thence following the curvature of the Southeastern intersection of Indigo Street with Woodbriar Court (the chord of which is S 83-52 W 21.4 feet) to a point; thence with the Southeastern side of Woodbriar Court S 39-25 W 60 feet to the point of beginning.
