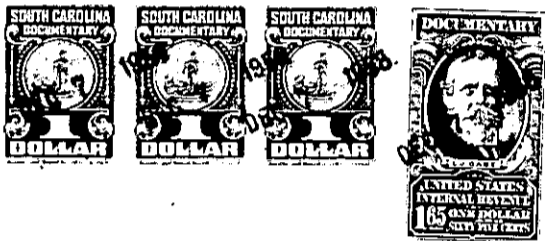
That I, George F. Townes, as Trustee in the State aforesaid,
