That I, J. B. BANKS

in consideration of the sum of One Dollar with love and affection in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said PINK W. BANKS, his heirs and assigns, forever:

ALL that certain tract of land, situate, lying and being near the City of Greenville, in the State and County aforesaid, on the Northeastern side of Edgemont Avenue Extension, consisting of 3.0 acres more or less, known as Tract #6 of the J. B. Banks Property, according to a plat made by C. C. Jones & Associates, Engineers, in December, 1956, recorded in the RMC Office for Greenville County, S. C. in Plat Book LL at Page 151, and being described by metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Edgemont Avenue Extension, joint front corner of Tract #6 and a lot or tract conveyed by the Grantor to Gladys B. Mull on January 15, 1955, in Deed Book 518, at page 59, RMC Office for Greenville County, S. C., (a front part of which lot or tract was on the same date conveyed by Gladys B. Mull to Carol Ann M. Murphy) and running thence along the line of said Carol Ann M. Murphy and Gladys B. Mull, N. 57-22 E. 588 feet to an iron pin; thence S. 33-25 E. 192 feet to an iron pin on the line of tract #7; thence running along the line of tract #7, S. 52-34 W. 583.7 feet to an iron pin on Edgemont Avenue Extension; thence running along said Avenue, N. 34-45 W. 241.4 feet to an iron pin, the point of beginning.

The above described tract is a portion of that tract conveyed to J. B. Banks by E. Inman, Master on February 9, 1931, by deed recorded in the RMC Office for Greenville County, S. C., in Deed Book 140, at Page 248.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
