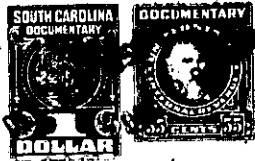

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

M. P. Hawkins, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about two miles northwest from Greer, S. C. lying south from South Tyger River and on the south side of the 850 elevation water right line of the Reservoir of the City of Greer, and being a part of a 40.52 acre tract of land conveyed to me by deed from J. R. Pollard, and being shown and designated as lot No. 6 on plat of property of L. E. Pollard made by H. S. Brockman, Surveyor, December 14th 1956, and having the following courses and distances, to wit:-

Beginning on an iron pin on the 850 elevation line, and runs thence with the said elevation line, N. 86-00 E. 152 feet to a stake; thence still with the said elevation line N. 63-19 E. 79 feet to an iron pin, joint corner of lots Nos. 6 and 7; thence with the common line of lots 6 and 7, S. 12-13 E. 165 feet to an iron pin joint corner of lots Nos. 6 and 7; thence S. 66-47 W. 100 feet to an iron pin; thence N. 74-21 W. 100 feet to an iron pin; thence N. 28-44 W. 144 feet to the beginning corner, containing Seventy Three One-hundredths (0.73) of one acre, more or less.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
