

A. L. Whitten, Jr. and Lillian H. Whitten, their heirs and assigns forever;

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina situate, lying and being in the City of Greenville on the southern side of Townes Street Extension (now known as Hindman Drive) and being known and designated as Lot No. 11 of Property of J. H. Mauldin as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "Y", Page 73 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Townes Street Extension (now known as Hindman Drive) at the joint front corner of Lots Nos. 11 and 12 and running thence along the southern side of Townes Street Extension and following the curvature thereof, the chord of which is N. 77-08 E. 90 feet, to an iron pin at the joint front corner of Lots Nos. 10 and 11; thence along the line of Lot No. 10 S. 12-54 W. 229.2 feet to an iron pin on the northern side of an alley; thence along the northern side of said alley N. 79-54 W. 55 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence along the line of Lot No. 12 N. 5-03 E. 194.5 feet to the beginning corner.
