

Stahl and Callie H. Stahl and their heirs and assigns forever:

All those two certain lots of land situated in Chick Springs Township, Greenville County, State of South Carolina, veing known and designated as Lots Nos. 48 and 49 in what is known as Woodland Heights, property of the I.M. Wood Estate as shown on a subdivision and plat of same made by H.S. Brockman, Reg. Surveyor, dated October 28, 1955, said plat being of record in the R.M.C. Office for Greenville County in Plat Book GG, page 151, and having the following metes and bounds and courses and distances as shown by said plat, to-wit:

BEGINNING at an iron pin at the Southwest corner of the J. Waymon Smith Road and Bessie Avenue and running thence along the Southern line of said Avenue S. 45-18 W. 248 feet to an iron pin at the corner of lot No. 47; thence along the Eastern boundary of this lot 190 feet to the joint rear corner of Lots 23, 48, 47 and 24; thence N. 45-18 E. 250.2 feet along the Northern line of Lot 23 to an iron pin in the Western line of the J. Waymon Smith Road; thence along the Western side of said road N. 39-55 W. 190 feet to the beginning point.

The above lots are hereby conveyed subject to the Protective, Covenants applicable to allthe lots in this subdivision known as Woodland Heights, near Greer, S.C., which are of record in the R.M.C. Office for Greenville County in Deed Book 539, page 129.
