

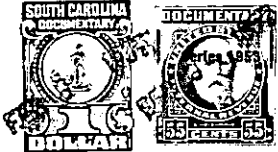

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 17 on a plat of property of Marsmen, Inc., recorded in the R.M.C. Office for Greenville County in Plat Book "O" at page 7, and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the South side of Buncombe Road, joint corner of Lots Nos. 17 and 18, and running thence with line of Lot No. 18, S. 27-24 W. 200 feet to an iron pin in line of Lot No. 3; thence with line of Lot No. 3, S. 62-53 E. 25 feet to an iron pin, joint corner of Lots Nos. 16 and 17; thence with line of Lot No. 16, N. 27-24 E. 200 feet to an iron pin on the South side of Buncombe Road; thence with Buncombe Road, N. 62-53 W. 25 feet to an iron pin, the beginning corner.
