

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Thirteen (13), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is: of record in the R. M. C. Office for said County and State in Plat Book "EE" at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the Southwestern side of Richbourg Road

South 47-40 West along the dividing line between Lots 12 and 13, and running then (200.0) feet to an iron pin at the corner of Lots 10 and 13; thence North 42-(125) feet to an iron pin; thence North 47-40 East two hundred twenty-five iron pin; thence South 42-20 East along said Richbourg Road to the place of beginning, which is one hundred twenty-five (125) feet.
