All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Thirty-Eight (38), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plate is hereby made, said lot of land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the Southwestern side of Richbourg Road as shown on said plat at the corner common to Lots 37 and 38, and running thence South 55-58 West along the dividing line between lots 37 and 38, two hundred fifteen and eight-tenths (215.8) feet to an iron pin; thence North 42-58 West one hundred thirty (130.0) feet to an iron pin common with Lots 38 and 39; thence North 58-25 East along the dividing line between Lots 38 and 39, two hundred thirty two and seven-tenths (232.7) feet to an iron pin; thence along said Richbourg Road South 35-25 East one hundred nineteen (119) feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R. M. C. Office for said County and State in Deed Book 470 at page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restriction: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed".
