Know All Men by These Presents:

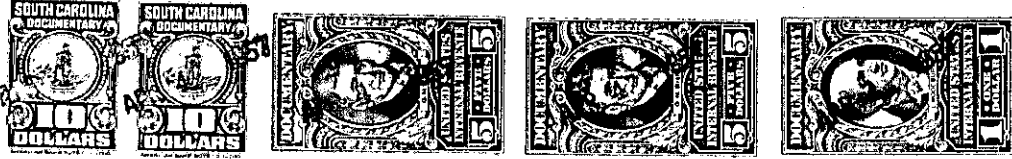
That I, Paul J. Bass, in consideration of the sum of TEN THOUSAND & NO/100 (\$10,000.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Walter W. Goldsmith

ALL That certain piece, parcel or lot of land situate, lying and being on the Southeast side of Woodland Way in the City of Greenville, County of Greenville, State of South Carolina, and having according to a survey made by Piedmont Engineering Service, August 30, 1949, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the southeast side of Woodland Way, said pin being at the northeast corner of lot now or formerly of Mary S. Guess, said pin also being 420 feet in a northeasterly direction from the point where the Southeast side of Woodland Way intersects with the northeast side of a 20 foot alley and running thence along the southeast side of Woodland Way, N. 57-30 E. 100 feet to an iron pin; thence S. 26-00 E. 260.6 feet to an iron pin on the northwest edge of Hemlock Drive; thence along the northwest edge of Hemlock Drive, S. 59-29 W. 75 feet to an iron pin on Hemlock Drive at southeast corner of said Guess property; thence along the line of Guess property, N. 31-30 W. 256.4 feet to an iron pin on the southeast side of Woodland Way, the beginning corner.
