love and affection for our brother to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

John Hoyt Henley, for the term of his natural life and then to D. Thomas Henley, his heirs and assigns forever:

All that lot of land, with the improvements thereon, situate in Fairview Township, County of Greenville, State of South Carolina and containing 2-1/2 acres, more or less being a portion of land in accordance with a plat made by W. J. Riddle for J. I. Henley dated Sept. 27, 1933 and to be recorded in the R. M. C. Office for Greenville County and being more fully described as near as possible in accordance with said plat, to-wit:

Beginning at the beginning stake as shown on said plat and running S 30 W, 7 chains; thence N 62 W, 3.47 chains; thence N 30 E, 7 chains to stake; thence S 62 E, 3.47 chains to point of beginning.

This being a portion of the property as conveyed to J. I. Henley by deed recorded in deed book 137, page 181 and passing to the grantors above as the sole surviving heirs of J. I. Henley who died intestate in the County of Greenville on the day of 19 as shown by probate court records.

The grantor, John Hoyt Henley, also signs this deed in order to dispose of any fee interest he might have in the property and to take it subject to the life estate as above stated.

Reference should be had to plat recorded in Plat Book "00" at page 1.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
