in consideration of the sum of THREE THOUSAND AND NO/100-----(\$3,000.00)-----DOLLARS,

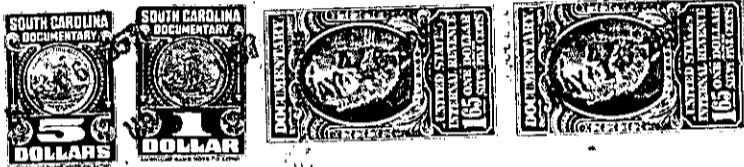

D. ROOSEVELT CARLTON and DORIS MAE CARLTON, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 4 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Marion Road at the joint front corner of Lots 3 and 4 and running thence N 58-58 W 161.8 feet to a point at the joint rear corner of Lots 3 and 4; thence S 22-17 W 70.8 feet to a point at the joint rear corner of Lots 4 and 5; thence S 58-58 E 150 feet to a point on the Northwestern side of Marion Road at the joint front corner of Lots 4 and 5; thence with the Northwestern side of Marion Road N 31-52 E 70 feet to the point of beginning.
