All that piece, parcel or tract of land in Paris Mountain Township, Greenville County, State of South Carolina being known as a portion of Tracts Nos. 5 and 6 of the property of J. H. Walker estate and shown on a plat by J. C. Jones and Associates, May 9, 1956, said plat being recorded in the S. C. Office for Greenville County in Plat Book 117, at page 117, and said plat being revised June 6, 1957 by J. C. Jones and Associates, said revision being recorded in the S. C. Office for Greenville County in Plat Book NN, at page 147, and having, according to said plat, the following metes and bounds, to-wit:

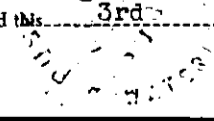
