to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MAYLON MYERS, his heirs and assigns, forever:

ALL that piece, parcel or tract of land, situate on the Southeastern side of Sentell Road, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 2 on plat of Riverdale, made by Dalton & Neves, Engineers, July, 1957, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", page 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeast side of Sentell Road at joint front corner of Lots 1 and 2, and running thence with the line of Lot 1, S. 26-58 E., 188.9 feet to an iron pin on the North side of an unnamed 36-foot alley; thence along said alley, N. 86-49 E., 120 feet to an iron pin; thence leaving said alley and running with the line of Lot 3, N. 29-49 W., 248.5 feet to an iron pin on the Southeast side of Sentell Road; thence with Sentell Road (the chord being S. 56-42 W., 97.8 feet) to the point of beginning.

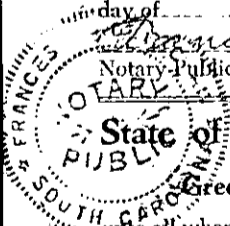
